## **Privacy Policy**

Crossroads Good News, and affiliates ("CRGNEWS", "we", or "us") is a Christian, nonprofit organization committed to excellence, integrity, and your privacy. This Policy is provided to inform you of the ways CRGNEWS collects, uses, discloses and otherwise processes or handles your personal information. By providing your information, you agree to your personal information being processed in accordance with this Privacy Policy, as amended from time to time (as noted in the date above).

#### INFORMATION COLLECTION AND USE

CRGNEWS collects some information that cannot be traced back to a specific individual (when that person is not signed in with an account). For example, our web servers automatically record the IP address (the general location where the user is logged) of each visitor to our website, EMAIL, and tracks how many people visit the Website. This information is used to administer and specialize the Website more effectively and gain general information about the backgrounds and sources of visitors. This policy also applies to information we collect when you contact us by telephone, mail, email, mobile application, and social media. CRGNEWS may also ask you to provide personal information that identifies you. We require this information when you create an account, submit an inquiry to us, become a partner, make a purchase or donation, or engage with us for promotional purposes. Such information could include your name, postal address, phone number, email address, date of birth, marital status, other demographic information, or credit card information. CRGNEWS limits the personal information it collects to that which is reasonable under the circumstances, and we only collect your personal information with your consent.

We use your personal information for processing your donations and purchases as well as informing you about upcoming ministry events or opportunities to serve, etc. We may otherwise use your personal information where permissible by law, for example to respond to an emergency, or in the course of an investigation into illegal behavior. You can cancel this service at any time. After you send the message STOP, you will receive a reply message to confirm that you have been

unsubscribed. After this, you will no longer receive messages from us. If at any time you forget what keywords are supported, After you send the message HELP, you will receive a response with instructions on how to use our service, including how to unsubscribe. ### COOKIES AND SIMILAR TECHNOLOGIES

Cookies are small pieces of text used to store information on devices that visit websites. Other technologies, including data we store on your web browser or device, identifiers associated with your device, pixel technology (e.g., Facebook pixel) and other software (Google Analytics and Google AdWords), are used for similar purposes. In this policy, we refer to all of these technologies as "cookies." CROSSROADS GOOD NEWS uses cookies in various ways, as followed: Authenticating and identifying you on our websites so we can provide you with the services you requested, including location services.

Keeping track of information, you have provided to us. For example, your favorites, shopping cart, wish lists, etc. Measuring your use of the websites so that we can tai|or your experience to your interests, and improve our service on the Website, apps or social media platforms. To help us keep your account, data and the website safe and secure. Some browsers have "do not track" features that allow you to tell a website not to track you. These functions are not uniform. Note that if you disable cookies certain features on our sites may not work. If you block or reject cookies, not all of the tracking described here will stop.

## THIRD PARTY SERVICE PROVIDERS

There are times when CRGNEWS uses trusted third-party service providers to help us collect and process information. These third-party Processors may have access to, store, or process Personal Data or Client Data as part of providing those services for us. We limit the information provided to these service providers to that which is reasonably necessary for them to perform their functions. Our contracts with them require them to maintain the confidentiality of such information and conform to our privacy standards. Some of these third parties may be located outside of the country you reside in, and as a result, that country's courts, governments or law enforcement agencies could obtain disclosure of your information in accordance with that country's laws.

### INFORMATION SHARING AND DISCLOSURE

We will not rent, sell, lease, or share personal information with other organizations, except for service providers referred to in the preceding section or except in response to subpoenas, court orders, legal processes, or to establish and/or exercise legal rights.

### SAFEGUARDS AND RETENTION

We take all reasonable steps to protect the security and confidentiality of your personal information. We protect the personal information within our custody or control with appropriate organizational, technological and physical safeguards. We store personal information in electronic and physical files that are secure, and our security measures include secure on- and off-site storage, restricted access to records and data processing equipment, password protocols, and encryption and security software. We conduct audits and monitor compliance with our privacy practices. If you live outside of the United States, please be aware that you are sending information (including Personal Data) to the United States where our servers are located.

We will protect it with the same protocols listed above. We only retain personal information for as long as is necessary for the purpose for which it was collected. Legal requirements, however, may require us to retain some or all of the personal information we hold for a period of time that is longer than that which we might otherwise hold.

#### THIRD PARTY LINKS

The Website may contain links to other websites operated by third parties. Please note that this Privacy Policy applies only to the personal information that we collect or receive from third parties with your consent, and we cannot be responsible for personal information that third parties may collect, store and use, including through their websites. You should always read the privacy policy of each website you visit carefully.

#### CHILDREN'S POLICY

We do not knowingly collect children's personal information. Users under the age of 16 must ask parent or guardian permission to use this Website, request information from CRGNEWS, or purchase any resources on this Website.

CRGNEWS strives to keep all personal information complete, up-to-date and accurate. #### Consent

We will only collect your personal information when we have your consent, which may be implied or expressed, or as otherwise permitted or required by applicable law. You may withdraw your consent at any time on reasonable notice with the exception of specific circumstances (e.g., this would frustrate our performance of a legal obligation). Please note that withdrawing consent may result in us not being able to provide you with some services that would require the processing of your personal information.

### **Data Transfers**

Please note that your personal information may be transferred to affiliated entities located in the United States. While your data is stored or processed in the United States, it will be subject to local laws, which may be less protective of your personal information than Canadian laws, as well as subject to potential access by US law enforcement.

### Children

This Website is not intended for use by, and we do not knowingly collect the personal information of anyone under thirteen (13) years of age.

# Rights to Access and Accuracy

We will make all reasonable efforts to ensure that your personal information is accurate and complete. You have the right to request access to your personal information and learn about how information is being used. We will provide you with such access within 30 days of your written request or information about an extension if we anticipate that it will take us longer than that period. You also have the right to request that we correct your information (in writing). If the information is demonstrated to be inaccurate or incomplete, we will correct the information as required. If the correction is not made, we will note the individual's correction request in the file.
